

NY KNICKS “2019-20 TICKET PLAN” SWEEPSTAKES (the “Sweepstakes”)

OFFICIAL RULES

**NO PURCHASE NECESSARY. VOID WHERE PROHIBITED.
A PURCHASE WILL NOT IMPROVE YOUR CHANCES OF WINNING.**

1. **PERIOD:** Sweepstakes begins at 3:00 p.m. Eastern Time (“ET”) on March 18, 2019 and ends at 11:59 p.m. ET on May 3, 2019 (the “Sweepstakes Period”).

2. **ELIGIBILITY:** Sweepstakes is open to legal U.S. residents of New York, New Jersey and Connecticut, at least eighteen (18) years old at time of entry, who reside within a 75-mile radius of the arena at Madison Square Garden (the “Arena”). Sweepstakes is void outside the area stated herein and where prohibited by law. Directors, employees, and the immediate family (spouse, parent, sibling, children, grandparent or grandchildren and their respective spouses, regardless of where they reside) and/or household members of individuals, whether or not related, employed by New York Knicks, LLC (the “Knicks” or “Sponsor”), MSG Sports & Entertainment, LLC (“MSG”), The National Basketball Association (the “NBA”), the NBA Member Teams, NBA Media Ventures, LLC, NBA TV, LLC, and NBA Enterprises, LLC (collectively, the “NBA Entities”), and all of their respective parents, subsidiaries, affiliates, directors, officers, employees, advertising and promotional agencies, are ineligible to participate. Sweepstakes is subject to all applicable federal, state and local laws.

3. **TO ENTER:** Limit one (1) entry per person regardless of method of entry.

(i) **Method #1:** During the Sweepstakes Period and in connection with the 2019-20 New York Knicks season, individuals who make a deposit towards the purchase of an offered ticket plan by 11:59 p.m. ET on May 3, 2019 will be entered for a chance to win. Ticket plan subscriptions can be purchased (I) online at nyksubcentral.com, (II) by phone at 212-465-6050 or (III) by mail by sending a completed purchase invoice (as provided by the Knicks) to Madison Square Garden, Season Subscriptions Department, 2 Penn Plaza, 14th Floor, New York, NY 10121.

(ii) **Method #2:** To enter without making a deposit towards the purchase towards the purchase of an offered ticket plan for the 2019-20 New York Knicks season, an individual may print his/her full name, date of birth, e-mail address, street address (including city, state and zip code) and day and evening telephone numbers on one side of a 3”x5” index card, and mail it to: NY Knicks “2019-20 Ticket Plan” Sweepstakes, Two Pennsylvania Plaza, 14th Floor, New York, NY 10121.

Multiple entries from any person will be void. Entries generated by script, macro or other automated means or by any means which subvert the entry process are void. All entries become the property of Sponsor and will not be acknowledged or returned.

4. **SELECTION OF WINNER:** Sponsor will randomly select one potential winner from among all eligible entries on or around May 4, 2019 (the “Potential Winner”). Potential Winner will be notified by phone or email. Potential Winner must comply with all terms and conditions of these Official Rules, and winning a prize is contingent upon fulfilling all requirements. Potential Winner will be required to sign and return an Affidavit of Eligibility and Liability/Publicity Release within twenty-four (24) hours of the date of notice in order to claim his/her prize and become an official winner (“Official Winner”). If a prize or prize notification is returned as undelivered, prize remains unclaimed, Potential Winner cannot be contacted, fails to sign and return the Affidavit of Eligibility and Liability/Publicity Release within the required time period or is not in compliance with these Official Rules, the Potential Winner may be disqualified and forfeits the

prize. In the event that the Potential Winner is disqualified for any reason, Sponsor may award the prize to an alternate Potential Winner by random drawing from among all remaining eligible entries received. 5. PRIZE: One (1) Official Winner will receive an autographed Knicks jersey (Approximate Retail Value (“ARV”): \$375.

Actual ARV of autographed jersey may vary based on market fluctuation. Player who will autograph jersey will be determined by Sponsor in its sole discretion. Prize is awarded “as is” with no warranty or guarantee, either express or implied. Official Winner will be responsible for all federal, state and local taxes and fees and other costs and expenses associated with prize receipt and/or use that are not expressly included in the prize description. No cash or non-cash prize or other substitution, assignment or transfer of any prizes permitted, except by Sponsor, who reserves the right to substitute a prize or prize component with cash or another prize of comparable or greater value. All prize details are at Sponsor’s discretion.

GENERAL CONDITIONS: Released Parties (as defined below) are not responsible for lost, late, incomplete, inaccurate, stolen, delayed, misdirected, undelivered or garbled entries or emails or postage-due, damaged or illegible mail; or for lost, interrupted or unavailable network, server, Internet Service Provider (ISP), website, or other connections, availability or accessibility or miscommunications or failed computer, satellite, telephone or cable transmissions, lines, or technical failure or jumbled, scrambled, delayed, or misdirected transmissions or computer hardware or software malfunctions, failures or difficulties, or other errors or difficulties of any kind whether human, mechanical, electronic, computer, network, typographical, printing or otherwise relating to or in connection with the Sweepstakes, including, without limitations, errors or difficulties which may occur in connection with the administration of the Sweepstakes, the processing entries, the announcement of the prizes, or in any Sweepstakes-related materials. Released Parties are also not responsible for any incorrect or inaccurate information, whether caused by site users, tampering, hacking, or by any equipment or programming associated with or utilized in the Sweepstakes.
